

**Eurasian Bank JSC:**  
**Terms of the Draw of a Trip to**  
**the 151<sup>st</sup> The Open Championship at Liverpool for Two Promotion**

**1. General provisions**

1.1. The organizer of the **Draw of a Trip to the 151<sup>st</sup> The Open Championship at Liverpool for Two Promotion** (hereinafter referred to as the Promotion) is Eurasian Bank JSC (hereinafter referred to as the Bank), Eurasian Diamond Club.

1.2. The period of the Promotion: from 3 April 2023 to 15 June 2023.

1.3. The participants of the Promotion shall be all customers-residents of the Republic of Kazakhstan holders of MC World Elite metal/credit cards.

1.4. These Terms of the Promotion (hereinafter referred to as the Terms) determine the procedure for holding the Promotion, participating in the Promotion, determining the winners of the Promotion, as well as the procedure for awarding the prize certificate (hereinafter referred to as the certificate). These terms do not contradict the current legislation of the Republic of Kazakhstan.

1.5. The territory of the Promotion is not limited, all transactions conducted through POS terminals in trade and service enterprises, including those conducted abroad and on the Internet, shall participate.

**2. Prize fund**

2.1. The certificate is **a trip to the 151<sup>st</sup> The Open Championship at Liverpool for two.**

Package contents:

- Round-trip business class flights
- 5 days/4 nights stay in 1 room for 2 guests
- Transfers from/to Liverpool Airport
- 4 breakfasts at the hotel
- 4 dinners at the hotel and local restaurants
- Transfers from/to Royal Liverpool
- Tickets for The Open seats
- Tickets to the Grandstand on the 18th hole
- Playing golf on the Championship course

2.2. The monetary equivalent of the certificate shall not be issued by the Bank.

2.3. The right to obtain a certificate cannot be transferred to another person, except in cases provided for by the legislation of the Republic of Kazakhstan.

**3. Information about the Promotion**

3.1. Information about this Promotion shall be distributed by:

- placement on the eubank.kz Bank website, diamondclub.eubank.kz;
- placement on publicly available resources of the Bank partners.

#### **4. Rules of participation in the Promotion**

4.1. All transactions of customers-residents of the Republic of Kazakhstan, holders of MC World Elite metal/credit cards, who made transactions in the amount of at least 500,000 (five hundred thousand) tenge during the period from 3 April 2023 to 15 June 2023 (inclusive), shall participate.

4.2. Citizens who are not holders of a MC World Elite metal/credit card at the time of the announcement of the Promotion are required to:

- ✓ apply for the issuance of a MC World Elite metal/credit card from a Private Banking employee;
- ✓ get and activate the MC World Elite metal/credit card using the instructions attached to it;
- ✓ follow the rules of participation according to the requirements.

4.4. Transactions that shall not participate in the Promotion:

- cash withdrawal/replenishment;
- payments to the budget, payment of penalties, payment of customs duties;
- loan repayment;
- deposit replenishment;
- payment in the Bank Internet banking;
- transfer transactions on the card;
- payment for services via ATMs;
- casino payment;
- payment of utilities;
- replenishment of the electronic wallet;
- purchase of electronic money.

4.5. The number of transactions during the Promotion period per one (1) Participant shall not be limited.

4.6. The Participant is solely responsible for the data specified in the questionnaire (cell phone number, full name).

4.7. The receipt of the certificate by the winner of the Promotion shall not entail the termination of his/her obligations to the Bank.

4.8. Participants who have overdue debts on the Bank loan products shall be excluded from the list of winners. The closed cards of the Participants at the time of the draw shall be also excluded from the list of winners.

4.9. Transactions of returned goods/services shall be excluded from the list of Participants.

4.10 Bank employees and related persons of the Bank shall not participate in the Promotion.

## **5. The order of the drawing**

5.5. The drawing between the Participants of the Promotion shall be based on the principle of determining by random number generation and shall be performed in the presence of the commission members according to the reference number of the Participant's transaction registered in the Bank database during the period of the drawing.

5.6. Random number generation shall select the reference number of transactions on MC World Elite metal/credit cards, which shall be fixed on the screen and shall determine the Winner of the Promotion.

5.7. After the end of the draw, the commission members shall record the winning and reserve reference number of the transaction.

5.8. The results of the drawing shall be recorded by the commission in the relevant protocol of the results of the draw, which shall be signed by all the commission members.

5.9. The drawing of the certificate for the Promotion shall be held in closed mode without the admission of the Participants of the Promotion. The term is until 1 July 2023.

5.10. To conduct a drawing between the Participants of the Promotion, the Bank shall form a commission consisting of at least three (3) people.

5.11. The functions of the commission members shall include:

- ✓ conducting a drawing of the Promotion certificate;
- ✓ confirmation of the results of the drawing between the Participants of the Promotion by signing the relevant protocol indicating the winner.

5.12. The result of the drawing shall be final and shall not be subject to revision.

5.13. If the winner refuses to receive the certificate, the prize shall go to the reserve customer, etc.

## **6. Procedure and terms of receiving the prize fund**

6.1. As a result of the drawing, a personal manager assigned to a specific Private Banking customer, shall contact and report the result of the win.

6.2. Ownership of the Promotion certificate shall pass to the winner at the time of transfer of the certificate according to the certificate acceptance act (Appendix No. 1).

6.3. If the winner refuses the certificate of the promotion, the winner shall fill out the certificate of refusal (Appendix No. 2).

## **7. Final provisions**

7.1. The fact of participation in the Promotion confirms that the Participant fully agrees with these Terms.

7.2. The Bank reserves the right to use the names and photos of the winners for advertising purposes, the right to change the procedure for issuing the certificate and publish additional information about the Promotion.

7.3. The Bank reserves the right at any time, without prior notice and explanation of reasons, to block the possibility of participation in the Promotion of those persons who violate these Terms, including:

- ✓ take actions aimed at falsifying the results of the Promotion;
- ✓ commit actions regarded by the Bank as fraud, deception or other manipulations that entailed or may entail adverse consequences for the Bank and the Participants of the Promotion;
- ✓ they leave humiliating comments and insulting statements to the Bank, the Participants of the promotion, and distribute false information about the Promotion.

7.5. The Bank reserves the right to cancel or extend the Promotion at any time, as well as to change these Terms as it deems necessary. The Bank shall promptly inform the Participants about changes in the Terms of the Promotion.
